

Accomplishments

Economic Development

- Supported the allocation of roughly \$2.5m in OEV funds to provide a tax incentive to Project Mango, later revealed as Amazon
- Supported the allocation of \$1m in OEV funds to support TCC
- Supported a successful bid to host the 2026 World Athletics Cross Country Championships at Apalachee Regional Park
- Supported County's successful hosting of the NCAA D1 Cross Country National Championships
- Supported Comprehensive Plan amendments that would see development on the South side of Leon County see needed growth
- Supported the new FAMU Way Skateable Art Park
- Requested development community be involved in discussions of any new ordinances impacting businesses or construction
- Supported rezoning of old Kohls building to the new self-storage allowance
